## **Seagry Parish Neighbourhood Plan Information Statement**

A referendum relating to the Seagry Parish Neighbourhood Plan will be held on 6 May 2021.

The question which will be asked in the referendum is 'Do you want Wiltshire Council to use the neighbourhood plan for Seagry to help it decide planning applications in the neighbourhood area?'

The referendum area is identified on the map which is included alongside this information statement. The referendum area reflects the area that has been designated as the Seagry Neighbourhood Area.

A person is entitled to vote in the referendum if:-

- He or she is entitled to vote in an election of any Councillor of Wiltshire Council whose area is in the referendum area; and
- His or her qualifying address for the election is in the referendum area. A person's qualifying
  address is, in relation to a person registered in the register of electors, the address in respect
  of which he or she is entitled to be so registered.

The referendum expenses limit that will apply in relation to the referendum is £2378.56. The number of persons entitled to vote in the referendum by reference to which that limit has been calculated is 276.

The referendum will be conducted in accordance with procedures which are similar to those used at local government elections.

The specified documents are available for inspection through the means outlined below. Due to coronavirus restrictions these are presented in order of preference in the interests of public health:

- 3. **Deposit point documents**: in the interests of public health we would advise only to view documents via this means where all other options have been exhausted. If you wish to view documents at a deposit point, please follow the protocol outlined within Appendix 1 to this statement.

- A statement that sets out general information as to town and country planning including neighbourhood planning and the referendum;
- Map of the Seagry referendum area.

## Viewing documents at deposit points

If you wish to view the specified documents at a deposit point you must do so by making an appointment. The protocol for making an appointment and for viewing documents can be found below:

  - County Hall: County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JQ
  - Monkton Park: Monkton Park offices, Monkton Hill, Chippenham, Wiltshire, SN15 1ER.

When entering any of the above locations and when viewing document(s), you must always wear a face covering. You must also apply hand sanitiser prior to handling any of the documents. You will also be asked to wipe down the viewing area using the cleaning wipes provided after viewing the documents.
