UK Parliamentary Election for

DEVIZES CONSTITUENCY

1. An Election is to be held for a Member of Parliament to serve Devizes Constituency.
2. Nomination papers can be obtained from:

3. Nomination papers must be hand delivered to the Acting Returning Officer or his appointed staff, daily between the hours of 10am and 4pm from Tuesday 7 April 2015 until Thursday 9 April 2015 but no later than 4 pm on Thursday, 9th April 2015.
4. Nomination papers can only be hand delivered to the following 3 locations:
 - Main Reception at County Hall, Bythesea Road, Trowbridge BA14 8JN. Please ask for a member of the Electoral Services Team on arrival
 - Main Reception, The Council House, Bourne Hill, Salisbury, Wiltshire SP1 3UZ. Please ask for a member of the Electoral Services Team on arrival
 - Main Reception at Council Offices, Monkton Park, Chippenham SN15 1ER. Please ask for a member of the Electoral Services Team on arrival
5. The £500 deposit may be made either by the deposit of any legal tender, by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom or by debit or credit card or the electronic transfer of funds. American Express cannot be accepted.
6. If the election is contested the poll will take place on Thursday, 7th May 2015 together with the poll for Wiltshire Council Bromham Rowde and Potterne Unitary Division By-election.
7. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Monday 20 April 2015.
8. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5 pm on Tuesday, 21st April 2015.
9. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5 pm on Tuesday, 28th April 2015.
10. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Electoral Services, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN by 5 pm on Thursday, 7th May 2015. The physical incapacity must have occurred after 5 pm on Tuesday, 28th April 2015. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Tuesday, 28th April 2015.
